Where we refer to "process", it means how we collect, use, store, make available, destroy, update, disclose, or otherwise deal with your personal information. As a general rule we will only process your personal information if this is required to deliver or offer a service, provide a product or carry out a transaction.

We may combine your personal information and use the combined personal information for any of the purposes stated in this Privacy Policy.

In this document any reference to "we" or "us" or "our" includes ELEPHANT PLAINS GAME LODGE and any of its subsidiaries.

If you use our services, goods, products, and service channels you agree that we may process your personal information as explained under this Privacy Policy. Sometimes you may provide us with consent to process your personal information. Read it carefully because it may limit your rights.

Our commitment to privacy

Your privacy is important to us. It is our policy to never sell or trade your personal or contact information to marketers. To better protect your privacy, we provide this notice explaining our online information practices and the choices you can make about the way your information is collected and used.

This Privacy Policy has been developed in accordance with the South African Protection of Personal Information ("POPI") act and the EU General Data Protection Regulation ("GDPR").

PURPOSE OF THE PRIVACY POLICY

The purpose of the Privacy Policy is to provide clarity, transparency, and accuracy regarding the collection and use of an individual's personal data for which ELEPHANT PLAINS GAME LODGE may collect and use for processing.

THE WAY WE USE INFORMATION

We do make use of information that we collect about you or that you provide to us, including any Personal Information:

To present our Site and its contents to you better by gathering mostly of non-personal analytical data.

To provide you with information, products or services that you request from us. To provide customer service to you, it is necessary for us to disclose information to our affiliates and other agents and /or tour operators, DMC's that work with us. We do not share your information with outside parties except as provided herein and to the extent necessary to provide you service and maintain our Site.

To fulfil any purpose for which you provide information such as the completion of a contact form with minimal information in order to be able to get in touch with you and respond to your request or enquiry.

To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.

To notify you about changes to our Site or any product developments or changes to services we offer or provide through it. We may also use your information to contact you about our goods and services that may be of interest to you. If you do not want us to use your information in this way, please check the relevant box located on the form on which we collect your information (check-in app or any SMS/email marketing material, excluding conference and wedding information request forms through the website as those, are deemed to have been authorized by yourselves by requesting the stipulated information.). If we have sent you a promotional direct e-mail, you may also send us a return e-mail asking to be omitted from future e-mails and requesting the removal of your information from our database(s). BROWSER INFORMATION COLLECTED ON THE WEBSITE

We make use of Cookies on this website to track visits and hits by means of Google Analytics. Various elements of data sets may be collected to track the usefulness of certain actions and to ultimately improve the value to customers and broadened to make future decisions in the development or enhancement of this website. Please note that at no time does ELEPHANT PLAINS GAME LODGE gather, request, record, require, collect or track any type of Internet users' Personal Information (as listed above) through these processes.

SITE SECURITY

For site security purposes and to ensure that this service remains available to all users, the platform on which the Site resides on – commonly known as a "production environment", utilizes a wide-range of software tools and programs for the ultimate goal of ensuring its confidentiality, integrity, and availability (CIA) – a concept known as the CIA triad of information security. Tools which are currently in use, or are to be deployed if necessary for the security of the Site are to include, but are not limited to, the following:

Network Security and Network Monitoring: Tools that assist in securing the network on which the Site resides. Such tools include network and perimeter firewalls, web application firewalls, routers, switches, intrusion detection systems, and other related tools.

We collect several types of information from and about our customers and users of our Site, including information:

by which you may be personally identified, such as name, postal address, e-mail address or telephone number ("Personal Information");

that is about you but individually does not identify you; and/or

about your internet connection, the equipment you use to access our Site and usage details.

We collect this information:

Directly from you when you provide it to us.

Automatically as you navigate through the site. Information collected automatically may include usage details, IP addresses and information collected through cookies, web beacons, and other tracking technologies.

Credit card information is for the sole purpose to process the payment – we do not keep it on record as we use an authorised third-party merchant for these transactions who have in place their own privacy and data policies as well as terms and conditions of usage.

INFORMATION YOU PROVIDE TO US.

The information we collect may include:

Information that you provide by filling in forms on our Site. This may include information provided at the time of registering to use our Site, subscribing to our newsletter services, email registrations, or requesting further services. We may also ask you for information when you report a problem with our Site. responses to surveys that we might ask you to complete for research purposes.

Details of transactions you carry out through our Site and of the fulfilment of your orders.

Information that you may provide through phone, mail interactions or paper and mobile checkin applications that you submit to ELEPHANT PLAINS GAME LODGE via the Site.

PERSONAL INFORMATION WE MAY NEED TO MAKE A BOOKING:

Name and Surname - so we can address you in any correspondence.

Telephone number and Email – so we can contact you during the booking process and to send you follow-up communication to solicit your feedback and keep you updated with the latest stories and sightings from ELEPHANT PLAINS GAME LODGE.

Age – rates from suppliers and insurance premiums can differ according to the age of the person making the booking.

Country of residence – some suppliers vary rates by country of residence.

Credit Card information – to charge the booking once confirmed.

Preferences – Your personal food, beverage and other service preferences.

USAGE DETAILS, IP ADDRESSES, COOKIES.

As you navigate through and interact with our Site, we may automatically collect certain information about your equipment, browsing actions and patterns, including:

Details of your visits to our Site, including traffic data, location data, logs and other communication data and the resources that you access and use on the Site.

Information about your computer and internet connection, including your IP address, operating system and browser type. The information we collect automatically is statistical data. It helps us to improve our Site and to deliver a better and more personalized service. The technologies we use for this automatic data collection may include Cookies and Web Beacons. When you interact with ELEPHANT PLAINS GAME LODGE on our Site or otherwise, such as when you call our reservations or support staff, you may be required to provide financial information before booking accommodation through our Site. ABOUT COOKIES & PIXELS
